Rules and Regulations

- 1. Persons wishing to become members or renew their membership shall complete the official application form. Applicants are requested to submit the completed form to the manager.
- 2. On acceptance of the application and following payment, the applicant will receive a membership keytag which will remain the property of the Oranmore Lodge leisure club and upon termination of the membership for whatever reason will be returnable to the club on demand.
- 3. The membership of the club shall run for periods of 4, 6, 8 or 12 months as the manager may determine. The membership must be used within the period allocated. Time can only be redeemed through medical certification.
- Absolute discretion is granted to the owner or manager to reject an application or renewal of a membership and in such cases 4. any monies paid will be refunded.
- All Members and Guests must complete the clubs health declaration form. 5.
- 6. All subscriptions and charges for individual facilities shall be such amounts, as the owner in its sole discretion shall determine from time to time.
- 7. Each membership has a certain number of guest passes included. These passes must be used within the membership time and are non-transferable on renewal of the membership. The member must accompany the guest when using a pass.
- 8. The times at which any or all of the facilities may be closed at any time for the purpose of cleaning, decoration, repair or special functions. Management reserve the right to limit periods of time and number of persons using any area in the club.
- 9. A member introducing a guest to the club shall be responsible for the good conduct of such guests on the premises.
- 10. The right is reserved to make or vary such rules and regulations in relation to use and operation of the club as the owner and/or, manager may consider necessary.
- 11. The owner and/or manager may terminate any person's membership in the event of breach or non-compliance by such member with the rules specified herein, or made by the owner/manager from time to time.
- 12. All persons using and availing of facilities do so entirely at their own risk. Owner or management do not accept liability for loss, damage or injury in and around the building.
- 13. Single and partner membership are available to persons over the age of 18.
- 14. Family membership is available to two adults and two children under the age of 16 years. Children under 4 years are free. Extra children between 4 and 18 are charged per tariff.
- 15. No mobile phones, dogs (except guide dogs), cameras or video cameras are permitted at any time.
- 16. Persons considered being under the influence of alcohol or any controlled substance will not be permitted to use the facilities.
- 17. Management reserves the right of admission and has absolute right to remove any guest or member at any time.
- 18. No glass containers or food of any kind are allowed in the pool area.
- 19. Infants and children who are not yet toilet trained must wear an approved Swimming nappy.
- 20. Running, pushing, wrestling or causing undue disturbance in or about the pool area will not be tolerated.
- 21. Prams or buggies are not permitted in the gym or pool area.
- 22. Swimming hats must be worn in the pool. Running and diving is strictly prohibited at all areas. To maintain our high standards of hygiene, members are requested to shower before using the pool.
- 23. Adult members have full use of the leisure facilities, i.e. gym, swimming pool, sauna, Jacuzzi, Aerobics studio. Children under 16 are limited to the swimming pool only and to such classes that are organised specifically for them. Children will be requested to leave the pool by 8.00pm daily. Parents or guardians must directly supervise junior members of 14 years and under at all times.
- 24. A sauna and Steamroom are available. Instructions are posted in plain view of each room and must be complied with by those using the sauna and Steamroom. The owner or manager shall not be liable for the consequences.
- 25. Guests should not use these facilities if suffering from any of the following; serious illness, heart condition, high/low blood pressure, diabetes, a respiratory condition or any other medical condition which may affect your reaction with heat.
- 26. Guests taking medication for any of the above conditions, who are unsure as to the advisability of using such facilities, should consult with their GP first.
- 27. Correct attire and footwear must be worn in the gym, e.g. runners/ trainers, T-shirt, shorts/ leggings/ tracksuit. Members must bring a towel to the gym to wipe down equipment after use.
- 28. Everyone must consult with an instructor before using any gym equipment.
- 29. Complete a health status questionnaire and complete a gym induction covering operation of all equipment/ weights.
- 30. If you are feeling unwell or taking medication, DO NOT TRAIN, CONSULT YOUR GP.
- 31. At the sign of any chest pain, faintness or irregular heart beat while exercising STOP AND CONSULT YOUR GP.
- 32. Mobile Phones are not to be used while exercising on the Cardio Equipment in the Gym.
- 33. All members/ guests must adhere to the Covid 19 guidelines set out by management.
- 34. Under no circumstances are chrildren 14 & under allowed into the Pool/Changing room unattended. As a parent/ guardian, I understand and agree that I am responsible for any child/ children using the facilities.
